As calculated in Part II of Schedule A, the Urban Non-Public Education Fund (the "Organization") failed to meet the 33 1/3% test, receiving 25.75% of its support during the period 2010-2014 from public support. This being so, the Organization still satisfies the requirement for non-private status as set forth in Code Section 1.170 A-9 (e)(3)(i)-(v) and (vii).

(i) The Organization normally receives more than 10% of its support from governmental units or from the general public.

(ii) The Organization is continually receiving contributions from first-time donors. Around 200 different donors have contributed at least once to the Organization in the past 5 years alone.

(iii) The Organization receives a small percentage of income through investments. It has been the contributions that put the percentage well over 10%.

(iv) The source of the Organization's support is not limited to any family, community, region, or interest.

(v) There is a Board of Directors that governs the Organization which consists of uncompensated members.

(vii) The activities of the Organization are likely to appeal to many different individuals and entities, especially those with an interest in supporting private education.

Because the Organization actively seeks broad public support for its charitable purposes and because the Organization is not organized or operated to benefit any single individual or his/her family, the Organization does satisfy the public support test as set forth in Code Section 1.170A-9 (e)(3).
